

Blake Fund for Young Sailors 50/50 Lottery

Full Terms and Conditions (as at August 2019)

1. Definitions

- The 'Club' – Emsworth Sailing Club Ltd., 55 Bath Road, Emsworth PO10 7ES
- 'Promoter' Tom Hulton, Emsworth Sailing Club, 55 Bath Road, Emsworth PO10 7ES
- Blake Fund for Young Sailors 50/50 Lottery is being promoted on behalf of the Club. The member of the Club responsible for the Lottery is the Promoter.

2. Eligibility to buy tickets

Only applicants who are 16 years of age, or older, are eligible to buy tickets. No more than 2500 tickets will be sold in any one calendar month. The Lottery is open to members, their families and friends;

3. Cost of tickets

Each ticket, which is valid for one month, shall be sold for £5.00, and thereafter each ticket may be renewed each month at a cost of £5 a month;

4. Payment for tickets

- 4.1 Tickets may be purchased by online bank standing order or bank transfer;
- 4.2 Ticket purchases by standing order shall preferably be for £60 per annum, (payable in advance) but can also be paid at the rate of £5.00 per month (in advance);
- 4.3 Bank standing orders may be cancelled at any time without affecting tickets already purchased in advance;

5. Identification of tickets

When first purchasing a ticket, an applicant will be given a unique ticket number which once issued will not be re-issued to a different applicant. If an applicant wishes to purchase more than one ticket per month another unique number will be issued;

6. Allocation of funds from ticket sales

- 6.1 Available funds from ticket sales shall be allocated on a monthly basis.
- 6.2 The remaining funds shall then be divided equally between prize money and revenue for the Blake Fund for Young Sailors. Any lottery expenses incurred by the Blake Fund for Young Sailors, including any bank charges incurred through the Lottery bank account, shall be paid out of the Blake Fund's revenue;
- 6.3 ***It is the intention of the Blake Fund to use its revenue generated by the Lottery to support our young sailors in their sailing ambitions and to encourage all young members to enjoy sailing and 'being on the water' which might otherwise not be possible.***

7. Allocation of prize money

- 7.1 Each month there shall be three monthly cash prizes valued at 18%, 12% and 6% of that month's prize money. The remainder of the month's prize money shall be accumulated into a single bonus cash prize which shall be paid out at the last month in each quarter of a calendar year.

8. Inclusion in the draw

- 8.1 All ticket numbers purchased or renewed during a calendar month shall be eligible for that month's draw for the three prizes;
- 8.2 Only those ticket numbers which have been purchased and renewed in all three consecutive calendar months of any given quarter shall be eligible for the quarterly bonus prize;
- 8.3 A list of all eligible numbers will be available on the Club's website and information Notice Board before each draw is made.

9. The draw

- 9.1 An up to date set of eligible ticket numbers and ticket holders shall be printed for each draw.
- 9.2 The draw for any given calendar month shall be made at 19.30 hours on the 2nd Friday following that month at Emsworth Sailing Club or at a day and time as decided and approved by the Flag Officers of the club and promoted to the ESC members
- 9.3 Tickets shall be drawn in descending value of prize money.
- 9.4 Once drawn, a winning ticket shall no longer be eligible for any other prizes in that month's draw;
- 9.5 Successful ticket numbers and ticket holders will be published each month on the Club's website;
- 9.6 All prizes will be paid by cheque or cash.

10. Disclaimer

Applicants may purchase and renew tickets on a regular basis. It is each applicant's responsibility to ensure that funds are available and instructions in place to ensure standing order payments are made on time. Neither the Club nor the Promoter is under any obligation to inform any applicant if, for whatever reason, payments for the tickets are not made successfully.

11. Disputes

Any dispute relating to the Lottery will be referred to the Flag Officers of the Club for resolution whose decision shall be final.

12. Changes to these Lottery Terms and Conditions

On the first anniversary of the first draw, and on each anniversary thereafter, the Club reserves the right to amend these Terms and Conditions, or to cease to run this Lottery. Any change will be published by the Club on its website.

13. Lottery registration

Blake Fund for Young Sailors 50/50 Lottery is registered with Havant District Council registration no. SL194.
